**FEBRUARY 3            VICTORIA FALLS**

On arrival at Victoria Falls airport you will be met and transferred to Shongwe Oasis Boutique Lodge for overnight in a deluxe room. Note you will need to get a double entry visa as you will be crossing the border into Botswana for a day tour.

Named for the Queen of England, but known locally as Mosi-oa-Tunya, “The Smoke Which Thunders,” Victoria Falls is a UNESCO World Heritage Site and one of the Seven Natural Wonders of the World. Twice the size of Niagara Falls, they are the largest sheet of water of any falls in the world. Victoria Falls also offers many hotels, restaurants and bars that welcome tourists and is well known for an abundance of adrenaline activities. While many initially come to see the magnificent waterfalls, more and more people who travel to Zimbabwe are choosing to stay to enjoy what this famous town has to offer.

**Accommodation: Shongwe Oasis Boutique Lodge, deluxe room – 4 nights**

**FEBRUARY 4            VICTORIA FALLS (B)**

Breakfast at the hotel followed by a morning tour of the falls.

We’re exploring Victoria Falls inside, outside, and right from the top - it’s a full tour, and you’ll thrill to every aspect of the fascinating stroll through the permanent gentle rain and mist occurring alongside the Falls, stopping off at the key view sites for a photo call! Here, you’ll be bombarded by the mighty roar of tons of water crashing over the series of ledges – it’s literally breathtaking.

Return to the hotel with the afternoon at leisure. Tonight you will have a sunset cruise on the Zambezi Explorer – Deck 1 & 2. Return to the hotel for overnight.

**FEBRUARY 5            VICTORIA FALLS (B)**

Breakfast at the hotel. Today you will have an Adrenaline High Wire Pass with return transfers included. Flying Fox/Zip Line/Gorge Swing.

**FEBRUARY 6            VICTORIA FALLS (BL)**

Breakfast at the hotel and begin your full day trip to Chobe National Park in Botswana with lunch included.

This is a sensational trip - land- and water-based game viewing. Your first game sighting is from The Chobe River, teaming with animals, you sitting securely on board, just off the riverbank, game viewing from the relaxing vantage point of a boat. You're on the mighty Chobe River which flows through the renowned Chobe National Park providing a haven for herds of grazing animals and bird life. Just sit back, relax, and keep those binoculars handy. Watch this glorious scene unfolding itself – large herds of elephant, often with the tiniest frolicking calves, kicking up dust as they wait their turn at the water's edge to drink.

Frighteningly large crocodiles sun themselves on the banks of the river, mouths agape, teeth terrifying. Glorious birdlife, wonderful game, and the gentle rocking of the riverboat. Can life get any better? Apparently. When we disembark, we join our open safari vehicle for a drive through the Chobe Game Reserve with the chance of seeing more wildlife and birdlife, and a gorgeous lunch at a lodge awaiting us.... overlooking the Chobe River. Let's call it the ultimate.

**Note: A passport is required and visa conditions may apply.**

**\* Guests are advised to request a double entry visa on arrival in Victoria Falls, which covers the day trip into Botswana.**

Return to your hotel for overnight.

#### **FEBRUARY 7            DURBAN (B)**

Breakfast at the hotel and transfer to Victoria Falls airport in time for your flight to Durban via Johannesburg. (flight not included) On arrival at Durban King Shaka Airport you will be met and transferred to your hotel.

**Accommodation: Oyster Box Hotel, classic sea-facing room – 3 nights**

#### **FEBRUARY 8            DURBAN (B)**

Breakfast at the hotel. Transfer to Phezulu Cultural Park (approx. 45min drive). Zulu dancing show (10am) and Reptile Park. Return to the hotel with the afternoon at leisure.

#### **FEBRUARY 9            DURBAN (B)**

After breakfast you will have a half day Durban city tour.

Our tour begins as we travel along Golden Mile, the revitalised beachfront promenade which hugs the beckoning beaches of Durban viewing the upgraded Point Waterfront. We move through the City, viewing the majestic City Hall, and enjoying its humorous history! We continue to the small craft harbour viewing the 8th largest harbour in the world. Return to the hotel with the afternoon at leisure.

Breakfast at the hotel. Transfer to Durban airport in time for your flight via Johannesburg to Hoedspruit (flights excluded) On arrival you will be transferred to Karongwe Private Game Reserve. Afternoon game drive and dinner back at the lodge. Overnight on a full board basis. Included is all meals, two daily game drives and conservation levies.

### **DEPOSIT & FINAL PAYMENT:**

#### **I. GROUP DEPOSIT:**

**In order to block land arrangements, a non-refundable deposit of USD\$1,000.00 must be received by our office, together with the signed booking form.** This amount will be deducted from the final invoice. If the group cancels, we will hold on file the initial deposit for up to 1 year to be transferred once to a future new group booking; sorry it cannot be transferred to an existing group and/or a new or existing FIT booking.

**Prices cannot be confirmed until all land and/or air arrangements have been booked as per the group's final itinerary.**

#### **II. ADDITIONAL DEPOSIT:**

At times, additional deposits may be required for your arrangements and at times this information may be advised after initial quote or confirmation. If applicable, we will advise you as soon as we are made aware of this by the supplier.

#### **III. DEPOSIT PAYMENTS:**

**All** deposit payments, for land and/or air must be made via agency cheque or credit card only / Group leader cheque or credit card only.

#### **IV. FINAL PAYMENT AND DOCUMENT ISSUANCE:**

Final payment and valid passport copies\* are due no later than 90 days prior to departure. For payments within 90 days of departure or if air tickets and documents need to be issued immediately after payment, a certified cheque, bank draft or wire transfer must be received. Normally air tickets and travel documents are sent out 30 days prior to departure.

The above are our normal final payment terms; however certain arrangements may require the balance of payment earlier.

**Important: \* These are required as per TSA requirements. Tickets cannot be issued without this information.**

#### **V. INSTALLMENT PAYMENTS:**

Goway Travel will accept installment payments on groups. Please note, any refunds of instalment payments that have been made over and above the non-refundable deposits will be subject to a 5% processing (e.g. a refund of \$500 will be charged a \$25 fee), a minimum charge of \$5 will apply. This processing fee applies if the cancellation is made prior to the effective date of the penalty period for the group. Please review the terms and conditions for full details of these dates and charges.

**VI. OVERPAYMENT/ADDITIONAL COMMISSION:**

Please note that any additional overpayment beyond 15% will be subject to an administration charge of 3% on the overage. This applies to NETT rates and also Gross rates where additional commission is added.

**INSURANCE:**

It is strongly recommended that clients purchase cancellation insurance to protect themselves against cancellation due to illness prior to or during travel. In the event a traveller becoming ill during a tour and has not purchased insurance, all hospital and medical expenses are the traveller's responsibility. Based on Goway Travel's current cancellation policies the passenger may incur up to 100% cancellation penalties and should protect themselves with cancellation insurance.

**Insurance MUST be purchased within 7 days of individual client deposits or payments being made and only covers non-refundable client money held by Goway Travel.** If the group cancels prior to final payment and supplier fees being applicable, due to the required minimum numbers not being reached, the premium is refundable providing no claim has been made. In all other cases the premium is non-refundable.

1. Goway Travel cannot sell insurance to clients who are non US or Canadian residents or if they reside in Quebec
2. We are unable to sell any insurance to residents of the State of New York or Hawaii

**IMPORTANT TRAVEL NOTES:**

**The Botswana Government have announced their intention to ban the use of plastic carrier bags effective from the 1st of November 2018. Guests travelling to Botswana should be aware of this and are advised to not carry plastic bags into the country. The proposed fine for carrying plastic bags will be US\$500.**

## **PASSPORT & VISA INFORMATION\*:**

Please ensure clients have arranged all documentation with the appropriate consulate well in advance of their departure from US and that passports are also valid for the minimum validity required for **ALL** destinations being travelled to. The information following only applies to the itinerary booked with Goway Travel and does not cover any independently arranged destinations.

### **I. PASSPORTS**

Passports must be valid for a minimum of **6** months from your scheduled return date.

Please ensure you have the correct documentation with you ready for check-in, security clearance and the boarding gates. For international travel, government regulations require all travelers over 16 years old to be in possession of a valid (return) air ticket, a passport and visa and health documentation (if required). Travelers without the necessary documents will be not be allowed to board to avoid flouting immigration rules. Customers travelling to international destinations must ensure that their passports are signed on the space provided at the bottom of the page that lists contact details. This is a requirement from various Immigration Authorities which you must adhere to.

**MUST** Passports must be valid for a minimum of 6 months from your scheduled return date.

Please note that visitors who wish to travel to South Africa must have a machine readable passport that is valid for at least 60 days after their intended return date from South Africa.

**MUST** have sufficient blank pages in passport. These pages must be completely blank, this is a requirement. This blank page does not include the page reserved for Observations, Amendments or Endorsements.

It's important to note that non-South African passport holders must have at least two (1) completely unused visa page for entry or departure endorsements by South African Immigration Service in their passport. Government regulations prohibit airlines from boarding travelers without the required blank visa pages, even if you hold a valid ticket and a valid passport.

Please note that if you are travelling to other countries, you will need additional blank pages

If you are traveling to Zimbabwe via South Africa, please ensure that you have at least 6 blank pages in your passport. South Africa requires two clean, consecutive pages for each transit through South Africa. You will need two pages to transit South Africa in each direction, and two pages to enter Zimbabwe.

For travel to Zimbabwe all domestic transactions should be settled in Zimbabwe dollars, in accordance with the Reserve Bank of Zimbabwe (Legal Tender) Regulations, Statutory Instrument 142 of 2019. Travelers may have to exchange U.S. dollars for Zimbabwe dollars at exchange bureaus; use of U.S. dollar cash for transactions in Zimbabwe is restricted. Bring cash sufficient for the duration of your trip; the importation of any currency into Zimbabwe by travelers is not restricted. However, all travelers are encouraged to complete a Customs Declaration Form (Form 47) and declare the currency in their possession at the time of entry.

Note that the amount of currency that a person who is about to leave Zimbabwe may possess, without authorization in the departure lounge of an airport or any other port is a total of USD \$2000 in any currency or combination of currencies or in bond notes or coins, unless declared/documentated upon entry.

### **TRAVELLING WITH CHILDREN TO SOUTH AFRICA**

New requirements, introduced by the South African Department of Home Affairs from 1 June 2015, specify that all minors (children under 18 years) are required to produce, in addition to their passport, an Unabridged long form Birth Certificate which shows the details of both parents for all international travel to and from South Africa. All documents must be originals or copies certified as a true copy of the original by a commissioner of oaths.

If only one parent is travelling with the child, he or she must also produce a sworn affidavit (issued no earlier than 3 months prior to travel dates) from the other parent registered on the birth certificate. The affidavit must authorize him or her to enter into or depart from the Republic of South Africa with the child. A copy of the parents photo ID needs to be attached to the affidavit. Other requirements apply to unaccompanied children.

These regulations will be strictly enforced by the South African Department of Home Affairs. Contact the nearest High Commission of South Africa before travelling to verify the latest requirements.

Further documentation may be required. Travelers will be asked to produce the required documentation at check-in for each flight.

## II. **VISAS**

Visa requirements applicable to this quotation are as follows: At the time of this quotation, there is no visa requirement to South Africa for US citizens. Clients are required to have two consecutive blank pages in their passport for South African arrival documents or they will be denied travel. For Zimbabwe a visa can be purchased on arrival.

*\*applies to US passport holders only. Please make sure that all destinations to be visited or transited verified with the applicable consulate(s) for entry requirements prior to departure, together with requirements for anyone travelling on non-US passports.*

## **HEALTH INFORMATION:**

- I. **COVID:** Your travel arrangements could still be impacted by COVID. It is your responsibility to keep yourself and members of your traveling party (travel companions) informed of, and meet, all requirements in relation to your trip and any COVID based restrictions. We suggest these are constantly monitored prior to, and until your trip is complete, as they can change at any time, even while travelling overseas. The purchase of travel insurance with Covid coverage is highly recommended.
- II. **Travelling with medicines:** Some countries have restrictions on travelling with medicines (prescriptions and/or nonprescription). It is the travelers responsibility to check these requirements.

## **GENERAL:**

### I. **CURRENCY AND PRICING FLUCTUATIONS**

This proposal is based on the current exchange rate(s). Should there be considerable currency fluctuations, we reserve the right to apply any necessary surcharges. In the event of any additional fuel surcharges by the Land Suppliers and/or airlines, we reserve the right to add these to the costs of the land package and/or airfare. Any applicable increases will be advised in writing prior to final payment. Prices are guaranteed once final payment has been made.

### II. **GROUP DEFINITION**

- a) Land: A minimum of 10 paying adult passengers travelling on the same itinerary/ arrangements.
- b) Air: For most airlines, a minimum of 10 paying adults departing on the same date and travelling to the same destination on the same flights. Return travel on the same date from the same destination, however, approximately 10-25% of the group size may be permitted to vary their return travel date depending on the airline rules. For deviations, the airfare is subject to current airfare levels and airfare guarantees do not apply.



- c) Should the number of passengers fall below the required minimum (10), the booking will be deemed as F.I.T. Travel. Our F.I.T. department will provide a revised quotation based on actual numbers of passengers travelling on the given program. The group quote and rates will no longer apply.

III. **TOUR ESCORT (LEADER) POLICY**

As defined separately in our land-only quotations and our air-only quotations. Costs will either include or exclude FOC (free of charge) land and/or air arrangements for a bonafide tour escort. The Escort must travel with the group in both directions when air is quoted. Any FOC air tickets are offered as per the airline's tour conductor policy. All air taxes must be paid for the FOC Tour Escort Ticket and will be included on the final invoice. Mileage points cannot be accumulated on a FOC ticket.

Goway Travel reserves the right to charge an amendment fee of USD\$50.00 per proposal, when in excess of 3 proposals, and where extensive amendments are required. Once the group has been booked and confirmed, supplier charges may also apply for any changes made.
